## **General Meeting 26 April 2006**

The Annual General Meeting of Rockwool International A/S was held on 26 April 2006 at Roskilde Kongrescenter.

At the General Meeting the annual report for 2005 was approved and the Management and the Board of Directors were discharged from their obligations.

The General Meeting approved the Board of Directors' proposal for distribution of profit with DKK 4.8 per share of nominal value DKK 10 each share.

Tom Kähler, Henrik Nyegaard, Preben Damgaard, Jan W. Hillege, Gustav Kähler and Jürgen Sengera were re-elected as member of the Board of Directors. The members of the Board elected by the employees are Connie Enghus, Peter Nørgård, and Lars Elmekilde Hansen.

The Board of Directors constituted itself after the General Meeting with Tom Kähler as the chairman and Henrik Nyegaard as the vice-chairman.

Ernst & Young, Statsautoriseret Revisionsaktieselskab, was re-elected as auditor of the Company.

The general meeting authorised the Board of Directors to allow the Company to acquire its own shares, including A shares as well as B shares, of a maximum nominal value of 10% of the Company's share capital, provided that the price of the shares at the time of purchase does not deviate by more than 10% from the most recent listed price, cf. section 48 of the Companies Act, such authorisation to be valid until the next annual general meeting.
